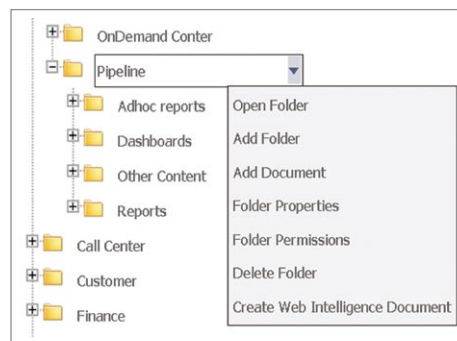


Figure 1: Intuitive Self-Service

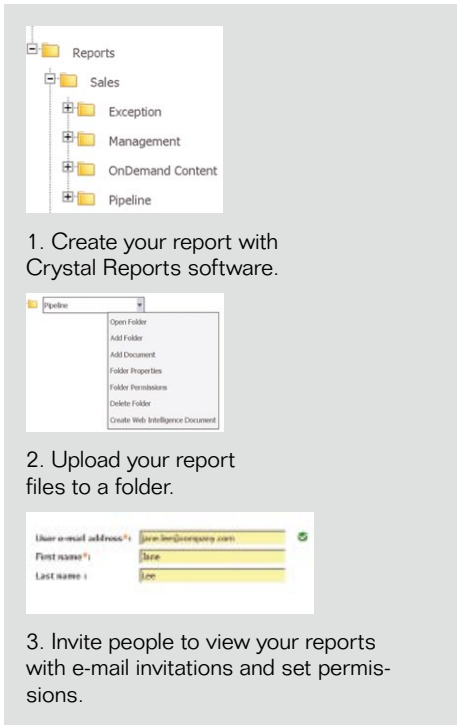


Figure 2: Simple Workflow for Sharing Reports
